Government Pharmaceutical Organization (GPO) conducts a medical cannabis project, in response to the policy of the Ministry of Public Health, in order to enable Thai people to have access to medical cannabis products which are effective, safe and reasonably priced. The first legalized medical cannabis cultivation to be undertaken in Thailand was at GPO, Thanyaburi District, Pathum Thani Province.

GPO conducted the whole supply chain of medical cannabis in accordance with the international guidelines comprise the following 7 G quality standards. GPO's medical cannabis cultivation facilities comprise of indoor and greenhouses with are certified with Good Agricultural Practice *(GAP)*. The production of medical cannabis extracts and GPO's medical cannabis sublingual drops are in accordance with GMP. At present, four types of GPO medical cannabis sublingual drops have already been included on the National List of Essential Medicinal Herbs B.E. 2021, which will help patients within the public health service system to reduce the expenses on medication and gain easier access to medical cannabis

Excellence Center for Advanced Therapy Medicinal Products (EC-ATMPs) is located in Bhumisiri Mangkhalanusorn Building at King Chulalongkorn Memorial Hospital (KCMH), the Thai Red Cross Society. This EC-ATMPs was obtained a Thai FDA-approved for manufacturing layout for production platforms of ATMPs, Medical devices for clinical uses with quality control platform having completed cell analysis evaluation including potency testing.

By joint management between the KCMH, which is a tertiary care hospital, and Faculty of Medicine, Chulalongkorn University, this manufacturing plant is a national center focusing on technology translation from laboratory research to clinical study based on quality development-based GMP manufacturing plant in accordance with FDA regulatory pathway to accelerate development of advanced medical products in Thailand for public uses.
